



## Family Benefits

The Application '**Family Benefits**' is an application that contains two modules to handle:

- ▲ Family allowances
- ▲ Pregnancy-maternity allowances

This application handles the benefits demands and right-holders files (assignees, recipients and beneficiaries) which are in the family cluster stocked in the application '**Registration**'. Children and spouses for instance are involved in the prenatal and maternity allowances as well as in the daily allowances and the medical expenses from the date the documents are submitted by the insurants or the right-holders until they are cleared and the files closed. Last step is being taken up by the application '**Benefits Payments**'.

The application main functionalities allow users to:

- Make an external configuration of the law, the ratio, transactions
- Handle the Family Benefits files,
- Manage the FB beneficiaries and their status changes,
- Follow up the files (Workflow) and the documents of evidence to maintain eligibility
- Send reminders and notifications to beneficiaries
- Take up the medical expenses
- Clear the allowances including the daily allowances,
- Validate and print FB files decisions

Main features are:

- The **traceability of the occurrences** in the module "follow up"
- The **consistency of beneficiaries data** stocked in the family cluster,
- The **clarity in the clearing rules**,
- The distinction between **automatic clearing process** and **adjustments process** with maximum precautions and safety when processing.
